Items for Discussion and/or Action:

A. Purchase of a two new lawn mowers from ERB in an amount not to exceed \$29,458.83*

This would purchase two new mowers (slope mower and a zero turn mower). Eight pieces of equipment will be traded in to reduce the overall cost of the purchase. Probst moved to approve the purchase. Seconded by Lyon. Passed unanimously.

B. CIP 2014-2019 revision*

Finance Committee Chairperson presented the revisions to the 2014-2019 CIP. Eleven (11) projects would have funding added to or would be created in the existing 2014 year in the CIP. Probst said that the Finance Committee had met to discuss the revisions to the CIP and recommended presenting the revisions to the full Board for their approval. Walendy moved to approve the revisions to the 2014-2019 CIP as presented. Seconded by Ryan. Passed unanimously

C. Budget Amendment #2, 2013*

Atkinson presented the information for budget amendment #2. The amendment would add \$85,000 to the 2013 CIP for replacing the surfacing at Booneslick and adding \$200,000 to the 2013 CIP so that additional asphalt work can be completed under the existing contract with Ford Asphalt. Ryan moved to approve Budget Amendment #2. Seconded by Lyon. Passed unanimously.

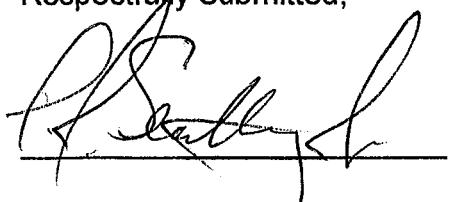

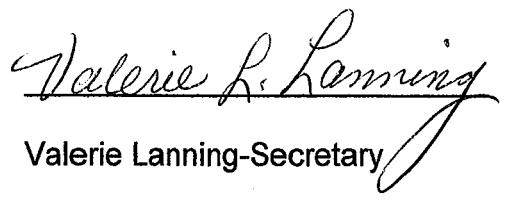
As there was not any other business to discuss Lyon moved for Adjournment at 6:40 pm. Motion was seconded by Probst. Passed unanimously.
